The minimum Qualifying Marks for Shortlisting of the candidates for Viva-Voice will be 25 Marks, final selection would be based on performance in the computer proficiency/skill test & Viva-voice. The time, date and venue of the test & Viva-Voice would be intimated through SMS, email, ITG website and will be displayed on the notice board of ITG.
- Final empanelment as Data Entry Operator shall be subject to the scrutiny and authentication of the documents submitted by the applicants.
