- Applicants should be present at the venue (ITG, 3rd Floor, IT HUB, Altinho, Panaji-Goa) within the reporting time mentioned. No Applicants will be permitted to enter exam centre after the reporting time under any circumstances.
- Applicant is required to be present on the examination day with their Hall Ticket. Applicant can download the Hall Ticket through registered login credentials from the website <https://infotech.goa.gov.in/APPOINTMENTS>. identification in original (Aadhaar Card, Voter ID, Passport, Driving License or any Government issued photo Id proof).

- Applicant should ascertain exact location of the venue well in advance of the date of examination. ITG will not be responsible for any delay or disruption in transport.
- The test will begin after completion of the formalities like checking of attendance, obtaining signature on the Hall Ticket and verification of photo identity proof of Applicant. The Applicant will have to affix his/her signature in the space provided, in the presence of the Supervisor/Invigilator.
- Applicant will not be permitted to leave the examination hall without prior permission of Supervisor/Invigilator. Applicant should strictly comply with the directions given by the Supervisor/Invigilator. If any applicant is found disregarding these directions, he/she shall be liable to be debarred from the test.
- All electronic devices including mobile phones, cameras, electronic watches, calculators etc. are not allowed at the examination center.
- The selection of applicants is further subject to the relevant rules in force.
- Note that Applicants are allowed to appear for examination only once with details of the last successful registration.
- Only those Applicants who pass the computer proficiency/skill test with a minimum marks will be called for Practical Examination. **The minimum passing marks for the skill test is 25 marks.**
- The marks allotted for the computer proficiency/skill test are 50 and for Practical Examination are 50. The final selection will be in order of merit based on the combined marks scored in the computer proficiency/skill test and Practical Examination. The date/time for Practical Examination will be informed later to shortlisted applicants.

- Decision of Managing Director shall be final incase of any dispute/discrepancies arises.
