- b) Attested copy of PAN Card.
- c) **Mode of Payment towards Tender Document Fee(TDF), eTender Processing Fee(TPF) & Earnest Money Deposit(EMD) to be paid online through e-Payment mode via :**
 - a. **National Electronic Fund Transfer (NEFT) / Real-Time Gross Settlement RTGS) / Axis Bank Over-the-counter (OTC). Tenderer requires download pre-printed Challan towards credit of ITG available on e-tender website and make its payment through any of their Bank.**
 - b. **Internet Payment Gateway (Debit/ Credit Card of type VISA, MASTERCARD or RuPay.**
 - c. **Net Banking: Payment can be made through the Internet Banking of Any Bank.**

- c) One Similar works , each of value not less than Rs 12,13,560/- of the estimated cost put to tender in last 7years.

Note:

- The term similar works means Aluminum /Wooden/Glass, partition works etc carried out for any public sector /Government/Autonomous Institution, etc.
- Eligibility criteria may be relaxed in case of poor response.

INSTRUCTIONS TO CONTRACTORS

1. The intending bidder must agree to terms and conditions of CPWD Form 6 & 7. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
2. Information and Instructions for bidders posted on website shall form part of bid document.
3. The bid document consisting of plans, specifications, the schedule of quantity of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website www.tenderwizard.com/GOA.
4. Those bidders not registered on the website mentioned above, are required to get registered beforehand. If needed they can be imparted training on online bidding process as per details available on the website.
5. The intending bidder must have / obtain a valid Class-III digital signature to submit the bid.
6. On opening date, the contractor can login and see the bid opening process. After opening of bids he will receive the competitor's bid sheets.
