COMPANY PROFILE

Info Tech Corporation of Goa Limited (ITG) formerly known as the Electronics Corporation of Goa Ltd. (ECGL) has been set up by the Government of Goa to promote overall growth of the state's economy through the use of Information Technology. From 1990 to 1996, the company did not carry out any activities and was therefore defunct. In 1996, Government decided to entrust the work of development of infrastructure for IT Industry to this Corporation and initiated its activities in 1997.

Info Tech Corporation of Goa Limited (ITGL) (erstwhile Electronics Corporation of Goa Limited) was incorporated on 18th April, 1990 with EDC Ltd., GIDC and GHRSSIDC as shareholders. From 14.03.2006 the Company became a Government company with Government of Goa holding major shares (80.47 percent) represented by Department of Information Technology.

Authorised Shares Capital of the Company 31st March 2010 is Rs. 17.50 Crores divided into 1,75,00,000 shares of Rs. 10/- each. The issued subscribed and paid up capital is Rs. 16.33 Crore. The shares are held in the following pattern:

1. SOFTWARE TECHNOLOGY PARK COMPLEX

ITG has set up a Software Technology Park Complex at a prestigious site at Verna industrial Estate at Verna. The STP is planned as a modern, state-of-the-art and high quality Technology Park and service units with all necessary infrastructure of roads, services and landscaping. The built-up space has been allotted for setting up of IT & IT enabled services in the STP Complex. The STP complex is located in a Eco Friendly Industrial Estate in the company of Multinational Companies. The Verna industrial estate is centrally located from all the major towns & centres of Goa and is close to the airport.

ITG constructed five buildings having total area of about 12,463.01m². All these buildings i.e. STP-I, STP-II, STP-III, STP-IV (Administrative Building) & STP V buildings have been sold to the parties as under:

2. RAJIV GANDHI IT HABITAT, DONA PAULA

The Rajiv Gandhi IT Habitat has been established over an area of approximately 70 acres of land, which is strategically located at Dona Paula. This is one of the most prestigious locations in Goa. It is situated just around 30kms from Goa Airport. This site is close to Goa University campus and 3 kms from the capital city of Panaji. The purpose of the Rajiv Gandhi IT Habitat is to provide state-of-the-art Hi-Tech facilities to promote software and IT enabled service units. The Rajiv Gandhi IT Habitat is set up to attract investment in the State of Goa, provide additional employment and create modern facilities.

The total area of the park is about 2,61,003 m² comprising of total 18 plots of different areas. Out of which, presently total 16 plots have been leased out to the parties at the rate of Rs. 4,600/- per square meters given below:
