1. Bids are invited by Info Tech Corporation of Goa Ltd (ITG) in two bids – Eligibility cum Technical bids and Financial bid from well established and reputed organizations / agencies / suppliers who fulfill the eligibility criteria and having sufficient infrastructure & Manpower and proven track record in the field of Supply, Installation and Commissioning of Router and Firewall for Goa Police Department. The router and firewall along with the necessary accessories has to be supplied, installed, tested, commissioned and maintained for the Goa Police Department and provide the necessary after sales service support (comprehensive onsite) at such site/s. Tenderer /Bidder should submit the proposal on the <https://eprocure.goa.gov.in>. The first part will consist of Eligibility cum Technical Proposal and the second part will consist of Financial Proposal.
2. Bidders should go through the website <https://eprocure.goa.gov.in> for understanding the e-tendering process and to know the process for submitting the electronic bids at the website.
3. Bidders need to have a Class 3 category Digital signature issued by a licensed Certifying Authority (CA) for e-Tendering Portal.
4. Complete bid document terms and conditions and tender form containing all the details has been published on the websites <https://infotech.goa.gov.in> and <https://eprocure.goa.gov.in>.
5. The Bids can be submitted up to date and time given in NIT.
6. An Earnest Money Deposit (E.M.D.) should be provided by the tenderer / bidder. The EMD has to be paid online before the last date and time for online submission of bids as given in the NIT. EMD in any other form will not be accepted.
7. Bids would be considered only in the prescribed form/ document. Bids not submitted in prescribed format will be summarily rejected.
8. The eligibility Bid will be opened as per schedule in NIT and in the presence of bidder / designated representatives of the bidder, if present. The qualifying bids of the eligibility evaluation process shall only be considered for further evaluation of the Eligibility cum Technical and Financial Bid. The Financial bid will be opened in the presence of the qualified bidders/ designated representatives of the bidder, if present on a separate date and time as mentioned in the NIT. In case there is a change in this scheduled date and/or time, then the

qualified bidders (eligibility cum technical bid) will be intimated about the date and time via letter/email/phone.

9. No contractual obligation whatsoever shall arise from the Tender Document/ bidding process unless and until a formal contract is signed and executed between the tendering authority and the successful bidder.

10. The Bidder shall be deemed to have satisfied himself fully before Bidding as to the correctness and sufficiency of its Bids for the contract and price quoted in the Bid to cover all obligations under this Tender.

11. It must be clearly understood that the Terms and Conditions and specifications are intended to be strictly enforced. No escalation of cost in the Tender by the Bidder will be permitted throughout the period of completion of contract.

12. CHAPTER 2 Eligibility Criteria & Mandatory Conditions

The bidder must fulfill the following eligibility conditions and must also submit documentary evidence in support of fulfilling these conditions while submitting the Eligibility Bid. The scanned copy/copies of these documents should be uploaded on the e-tendering website during submission of bids before its last date. Failure to comply with these requirements may result in the bid being rejected.

Note: Bidders should read these conditions carefully and comply strictly while sending/submitting their Bids.

ELIGIBILITY CRITERIA FOR BIDDER FOR THE PURPOSE OF QUOTING IN THIS TENDER:

Keeping in mind the local service setup and accessibility required to extend support, it is considered essential that the bidder should have a strong local presence, specifically authorized for this Tender / project. 1. LATE TENDERS:

Any Tender received by the Purchaser after the deadline for submission of Tenders prescribed by the Purchaser shall be rejected.

2. OPENING OF TENDERS BY PURCHASERS:

The purchaser shall download all the documents submitted by the Tenderer/Bidder and place the same in the presence of tenderer/bidder or his authorized representative who choose to attend, on due date. The Tenderers representatives who are present shall sign an attendance register.

In case there is a change in this scheduled date and/or time, then the technically qualified tenderers/bidders will be intimated about the date and time by a letter/email.

The financial bid of only those bidders who qualify in the eligibility cum technical bids process will be opened.

ITG's decision on the dispute in any way touching or concerning the tender will be final.

3. CLARIFICATION OF TENDERS:

To assist in the examination, evaluation and comparison of Tenders, the Purchaser may, at its discretion ask the tenderer/bidder for the clarification and the response shall be online e-tender website, e-mail or in writing. However, at no cost Tender clarification at the initiative of the tenderer/bidder shall be entertained.

4. CONTACTING THE PURCHASER:

No tenderer/bidder shall try to influence the Purchaser on any matter relating to its Tender, from the time of the Tender opening till the time the contract is awarded. This may result in the rejection of the Tender.

5. PURCHASER'S RIGHT TO ACCEPT ANY TENDER AND TO REJECT ANY OR ALL TENDERS:

The purchaser reserves the right to accept or reject any tender and to annul the tendering process and reject all tenders, at time prior to award for contract without assigning any reason whatsoever and without thereby incurring any liability to the affected tenderers/bidders on the ground for purchaser's action.

6. AWARDING OF CONTRACT:

1. ITG will award the work to the tenderer/bidder who has quoted the lowest rate. In case more than one offer with the lowest rate are received, ITG reserves the right to award the work to more than one bidder ie., Split the work among the bidders in equal proportions.
2. The decision taken by ITG in the process of tender evaluation will be firm and final.

7. PERIOD OF CONTRACT:

1. Tender shall remain valid for 6 months from the last date of bid submission prescribed by the purchaser.

8. TERMINATION OF THE CONTRACT

If the tenderer/bidder fails to fulfill its obligations under the contract, which includes non supply of the equipments, ITG reserves the right to select another tenderer/bidder to accomplish the supplies. Any costs, damages etc. resulting out of the same shall have to be borne by the outgoing tenderer/bidder. Violation of any of the terms and conditions of the tender / contract will attract forfeiture of Security deposit and cancellation of work order / termination of the contract.

9. TERMS AND CONDITIONS

- a. The submission of more than one tender under different names by one agency is prohibited.
- b. Incomplete and conditional tenders shall be rejected. Tenders that do not fulfill all or any of the above conditions will be liable for rejection.

- c. The tender submitted without valid EMD at the time of opening of the Technical Bid will be rejected.
- d. The technical details may please be submitted as per Technical Bid and rates in commercial bid.
- e. Suppliers must furnish information brochures, product catalogue and other technical literature in respect of their product. One full set of original manuals pertaining to every item of Hardware and Software (if any) are to be supplied. The manuals in respect of the Hardware items should also describe the basics of items including methods of connections, power feeding etc.
- f. Acknowledgement should be obtained from concerned department against the delivery & installation of the items. ITG will also appoint an officer from its Department who shall report to the Managing Director of ITG concerned. Any difficulty during the period of the project will be resolved by the concerned officer.
- g. ITG has the right to negotiate with the lowest tenderer.
- h. ITG has the right to split the requirements and place the order on one or more vendors.
- i. ITG has the right to carry out the inspection and verify the details submitted by the tenderer/bidder and in case the information submitted is found to be false the bid of such a tenderer shall be rejected.
- j. The quantities mentioned are approximate and may vary at the time of placing the order. No compensation will be paid on account of varying quantity.
- k. Conditional offers are liable to be rejected.
- l. ITG/Department will not make any advance payment. ITG will make the payment only on receipt of the items successfully delivered & commissioned and acknowledged by the respective nodal officer of the Client Department. The payment will be released only upon receiving the payments from the concerned client department.
- j. No other charges shall be payable except for the rate quoted for the quantity mentioned.
- k. No modification in the rates will be accepted/entertained except in case of changes made and agreed by the Goa Police Department.

- h. Delivery as per schedule should be completed within 30 days from the date of the order. In the event of any delay in adhering to the time schedule for delivering by the specific date, **the tenderer shall be liable for the payment of penalty @5% of tender value for per week of delay subject to 20% of tender value for the delayed period as liquidated damages to the Department. The day will be reckoned at the end of working hours.**
- m. Any delay beyond one week in adhering to the prescribed delivery schedule or failure to supply requisite material of **agreed quality and specifications would entitle the Department/ITG to cancel the order.** In such an event, the Department/ITG shall not be liable to pay any amount and the supplier shall not be entitled to recover from the Dept./ITG any amount by way of damages, loss or otherwise for such cancellation of the order but at the same time the Dept./ITG shall be entitled to recover the loss which the Dept./ITG may incur on account of non-delivery or late delivery or on account of placing orders with other suppliers and recover from the supplier the difference between the price at which it has been agreed to supply and the price at which the Dept./ITG is forced to place fresh orders.
- n. **The Earnest Money deposit (EMD) of Rs. 62,500/- (Rupees Sixty Two Thousand Five Hundred only)** The EMD of the non-successful tenderers will be returned. The EMD of successful tenderers/bidders will be returned on successful supply of items against the PO and further on submission of security deposit @ 10% of the PO value.

Tenders submitted without the EMD will be rejected.

- o. Security Deposit @ 10% of the total cost of Purchase order is to be deposited in the form of Bank Guarantee which will be retained by the ITG till the satisfactory completion of the work/warranty period. The Director reserves the right to forfeit the amount in case contractor fails to execute the order.
- o. **INSTALLATION:** Bidder shall be responsible for installation/demonstration wherever applicable and for after sales service during the warranty and thereafter. The installation shall be completed within a week from the date of intimation

regarding the arrival of the equipment in the institute. A penalty equivalent to 1% of the value of the goods will be levied for every week's delay in installation. No sub-contracting will be allowed for installation/ commissioning or maintaining system/ equipment/instrument during or after warranty period.

- p. Installation, demonstration has to be arranged by the supplier free of cost.
- q. The equipment is to be guaranteed for trouble free performance. The defects, if any, during the guarantee period are to be rectified free of charge by arranging free replacement wherever necessary. Any charges and or governmental levies on account of the replacement are to be borne by the supplier /agent.
- r. Force majeure Clause :- If any item during the currency of the contract, the performance in whole or in part by either party of any obligation under this contract shall be prevented or delayed by reasons of any war, hostility, acts of God (hereinafter referred as events) then provided notice of the happening of any such event is given by either party to other within 40 hours from the date of occurrence thereof, neither party shall, by reasons of such event, be entitled to terminate the contract nor shall either party have claim for damages against the other in respect of such non-performance or delay in performance/supply of goods.
